Second circular letter

In recent years, academic interest has grown in the various manifestations of commitment and transgression that have been developed in contemporary times and that are being raised today in the Western world. From a gender perspective, both options offer new profiles that challenge the boundaries between the public and the private realms, and bring the contradictions between the ideals and behaviours that women and men are demanded to meet. The classic debate on the two spheres is open to new interpretations when approached from the interest in commitment and transgression. Consequently, in the spheres of social, intellectual or political commitment, obedience to rules or even puritanism in the private realm enables and legitimises transgression in the public one; other times, a transgressive behaviour or proposals appear in both cases; and lastly, it can also occur that a radical or disruptive appearance hides conventional theoretical and ideological approaches.

In this Conference, we are interested in delving into these aspects from a perspective that encompasses different disciplines and fields of study. Those interested are invited to submit their contributions around the following central themes:

- ideas and representations
- new and old forms of expression of commitment and transgression

- reformulations between the public and private realms in migratory and exile contexts
- spaces and forms of sociability
